V. Reports/Updates

- A. Emergency Systems Quarterly Activity Report Jennifer Woodrow Jennifer Woodrow noted staffing changes that included the addition of EMS Administrator Becky Novak and EMResource Administrator Anya Grether to the team. She requested that hospitals complete the EMResource surveys for their facility every day by noon so that data can be submitted to the Governor. The Governor has signed the proposed EMS rules which will go into effect on September 11th, 2020. Mr. Martin Lansdale has transitioned roles and is no longer managing the Oklahoma EMS Information System (OKEMSIS); the position is currently being filled. Currently, no trainings are scheduled for either OKEMSIS or the Trauma Registry. The newest Trauma Fund handout is available in the meeting packet for review. Marva Williamson will be retiring as Trauma Fund Coordinator effective July 31st, 2020. EMS Director and the Oklahoma Trauma Education Programs (OTEP) training has been cancelled with hopes to rescheduled using a virtual format. If anyone is interested in attending the EMS Director training, please provide input on whether a full day or two half day classes are preferred. Since our last meeting, the Trauma Referral Center (TReC) has had its new contractor assume operations on March 1st, 2020 and is now up and running. The OTERAC date is currently tentative for October with more information to be provided as available.
- B. Quality Improvement Committee Quarterly Activity Report Jamie Lee Jamie Lee announced the Committee had not met since December due to weather and COVID-19. The last meeting was a state wide conference where 12 cases were reviewed and an educational piece was provide. The next meeting will be held this day after the RTAB.

At this meeting, the Committee discussed the Rural EMS Stroke Triage Algorithm and the Region 1 Trauma Plan, Bylaws, and Draft Stoke Plan. The purpose of this proposal is to establish and define a statewide process to address organizations that fail to respond to letters received from the Regional Continuous Quality Improvement Committee in order to encourage participation in continuous quality improvement activities as required by Title 63 § 1-2530.3 for the betterment of the Oklahoma State Trauma System.

<u>Tier 1</u>- Initial Letter from the Regional Continuous Quality Improvement (CQI) Committee is signed by the committee signatory (ies) and sent to the appropriate recipient named below.

EMS Agencies-Initial letter for system errors or queries will be sent to the Medical Director and the EMS Director on file with The Oklahoma State Department of Health (OSDH).

Hospitals- Initial letters for system errors or queries that occur related to the function of the Emergency Department (ED) will be sent to the ED Medical Director and the ED Director/ Manager. Initial letters for system errors or queries that occur related to the function of areas outside of the ED will be sent to the Chief Medical Officer/ Chief of Staff and Chief Executive Officer/ President.

Response deadline: 30 days from the documented receipt of the letter.

<u>Tier 2</u>- No response to the initial letter from the CQI Committee by the Tier 1 deadline.

OSDH staff will place a call to the authorized Regional Trauma Advisory Board (RTAB) representative to enlist help providing a reminder to the letter recipient to respond and communicate the new deadline for receipt.

Response deadline: 15 days from successful contact with RTAB representative.

<u>Tier 3</u>- No response to the initial letter from the CQI Committee by the Tier 1 deadline or reminder call from OSDH staff with the Tier 2 deadline (approximately 45 days from receipt of initial letter).

EMS Agency: Medical Director and the EMS Director on file with The Oklahoma State Department of Health (OSDH) as well as the appropriate License Owner/City Manager.

Response deadline: 15 days from documented receipt of the Tier 3 letter.
