This department has its own OPD (General Shalya, Anorectal, Orthopedic & Marma Chikitsa), IPD, Minor Operation theatre (Sastra Karma, Kshara Karma, Kshara Sutra, Agnikarma & Raktamokshana Units) and Major Operation theatre. There is specialized Kshara Sutra setup with large number of daily patients for a number of Kshara Sutra procedures. The Department imparts Under Graduate, DAN & P, Post Graduate and Ph.D education along with hand to hand surgical training. The CCTV facility of OT light with Camera, C-arm facility, Gastroscopy and Colonoscopy are also available in Major Operation theatre and connecting with the class room for live demonstrations of various surgical procedures by the students along with interaction. The Department is having 4 Ph.D Scholars and 21 PG Scholars.
