All applicants - Read the below information carefully. If you do not bring all required documents to your appointment, your case will be delayed. You may need to return to the U.S. Embassy or Consulate at another date and your visa may be delayed or denied.

Step 1:

Register for Courier Service

•This consulate requires visa applicants to pre-register for courier services. This service is for returning applicant passports and visas to them after the interview. After registering the applicant will receive an UID code.

Step 2:

Schedule and Complete a Medical Examination

- •You and each family member applying for a visa with you, are required to schedule a medical appointment with an authorized physician.
- •If during your exam the authorized physician determines that the applicant needs to go through an aditional process, you **must NOT** show up for the interview and you **must not** schedule another one until you are told otherwise.

Important:

After your exam, the doctor will send the exam results directly to the embassy. Any information related to your case will be delivered through email. Keep your information updated calling Visa Information call center

Step 3:

Gather Documents Required for the Interview

- •Every visa applicant no matter their age must bring certain documents to the interview, including photographs, the original version of all civil documents submitted to NVC, copies of those documents, and financial documents from the petitioner and any other financial sponsors.
