He leads WHA's courtroom advocacy efforts and guides legislative and administrative advocacy on legal and regulatory issues impacting hospitals and health systems. Stanford has a juris doctor from the University of Iowa College of Law and a masters of health administration from the University of Iowa College of Public Health.

SESSION DESCRIPTIONS

Whose Bucket is it—CVO, MSO, or Legal? Participants will gain a better understanding of how the CVO, MSO and Legal work together and method for deciding who should handle specific tasks. This session will take a deep dive into the internal workings of a CVO and how daily tasks can be structured. Participants will gain skills to communicate clear expectations and avoid conflict.

Blockchain 101 - The Future of Credentialing. Participants will gain a basic understanding of blockchain technology and how it can be used as a single source of truth for credentialing. Participants will leave the session with a better understanding of the MSPs role in leading digital transformation. Participants will learn basic terminology associated with blockchain technology and credentialing.

NAMSS Update. Participants will be able to describe the history of NAMSS, strategic initiatives, and impact on the industry. Elements of NAMSS Leadership and Volunteer Pathways will be identified to better support the profession. Verification benchmarks and grassroots efforts NAMSS supports to improve credentialing efficiencies will be discussed.

Managing the Stress of Change. Participants will learn to understand the meaning and causes of stress and change and how it impacts our lives. Gain an understanding of why we are resistant to change and how we can pivot our thinking about it and the effects of stress and change on our health and learn healthy ways to cope with it. Learn to embrace the ways in positive emotions play a valuable role in our well-being. Understand the effects of stress and change on our health and learn healthy ways to cope with it.

Laugh! Just for the HEALTH of it! Participants will learn the health benefits of humor and laughter. We will examine the large and small stressors we have in our lives and understand how to sort out legitimate challenges and unimportant ones that we can let go of the stress and worry about. And, learn the keys to good health and how to implement them.

A Risk Management Approach to Credentialing and Privileging. Participants will be able to identify the steps in a risk management approach to credentialing and privileging. We will look at defining the relationship between medical staff/credentialing and risk management and explore how to avoid legal problems by utilizing risk management.

A Project Management Approach to Revitalizing Your Privileges. Attendees will be able to identify the key components to a project management approach and explore the reasons for utilizing a project management approach. We will identify resources and approaches to project management, define the project management steps in a privilege revitalize project, and define the mechanism for developing new privileges and criteria.

Current Legal and Regulatory Updates. Participants will receive updates on legal and regulatory issues impacting hospitals and health systems.
